Framework agreements – Advanced chemicals





About the agreements

Aarhus University, University of South Denmark, Danish Technically University, Copenhagen University and Aalborg University has jointly completed a public procurement concerning advanced chemicals.

This Corporation mens better terms for each party given the combined procurement power.

The framework agreements enables purchase of a broad range of advanced chemicals which cover most needs.

The framework consists of an A assortment with fixed prices on specific products. Besides this the framework also gives the opportunity to make purchases from the supplier's B assortment where the supplier will offer a discount rate for products in specific categories.

The Framework is divided into the following sub agreements:

- Sub agreement 1: protein purification/proteomik
- Sub agreement 2: enzymes and inhibitors/substrates
- Sub agreement 3: RNA/DNA and PCR/qPCR/RT-PCR
- Sub agreement 4: Cloning
- Sub agreement 5: Microbiology, substrates and media
- Sub agreement 6: Cell culture
- Sub agreement 7: Electrophoresis/blotting
- Sub agreement 8: Biological buffer solutions, lysis buffer, water and other reagents for molecular methods and cleaning
- Sub agreement 9: Other reagents for labeling/staining and antibodies

There are several suppliers for each sub agreement, which must be used in priority order. Purchases must therefore generally be made from supplier 1. If supplier 1 cannot deliver the requested product, the

purchase is made from supplier 2, and if this also cannot deliver, the purchase is made from supplier 3, etc.

Examples where a supplier cannot deliver is:

- If the supplier cannot comply with the delivery obligations of the agreement.
- If matters of shape, color or function justify purchasing from supplier 2 rather than supplier 1, etc.

Fees

Orders under DKK 500 will be added a fee (maximum DKK 150).

Fees for wet ice and dry ice will also be added to the order.

The framework duration

The framework is effective from first of December 2023 and 2 years forward. Hereafter it is possible to extend the agreement for up to 2 years.

How to use the agreements

You will purchase directly from the A assortment in AAU E-procurement via catalogues or punchout.

The purchase must be made from the relevant supplier on the sub agreement:

The B assortment is purchased in AAU E-procurement via punchout.

Please contact the procurement unit if you need to make repeatedly purchases of other advanced chemicals that are not covered by the sub agreements.

The suppliers offer advising and guidance regarding the products.

Order confirmation

The supplier sends a written confirmation. On the confirmation, there will be a date for delivery.

Any changes shall be sent to the customer without delay and a change cannot be made without the acceptance from the customer.

If the ordered product has been discontinued, in the event of product changes or long delivery times, another product of similar standard must be offered immediately. In that case, the price must never exceed the price at which the ordered product is offered.

If a product ordered by AAU cannot be delivered, the supplier must, if possible, offer a replacement product. The replacement product must have at least the same quality and price as the product being replaced and must be delivered under the same conditions as the original product. AAU is not obliged to accept replacement goods. The supplier is not entitled to a cancellation fee or other compensation in connection with AAU's rejection of a replacement product.

Delivery Terms

Delivery time for orders concerning the A assortment shall be made as soon as possible and no later than 10 working days after submitting the order.

Delivery time for orders concerning the B assortment shall be made as soon as possible and no later than 20 working days after submitting the order.

Ongoing follow-up on the suppliers

The performance in the framework agreements is regularly evaluated.
